Orana generated a loss of \$35,000 for 2023-24 (2022-23 profit \$9,150). Whilst a loss is not ideal, it was anticipated.


To put Orana's facilities back into good order, post Covid, much overdue building maintenance and equipment repairs were carried out.

We have added new classes to our offerings including getting ready for work programs, sound bathing, English conversation classes as well as offering monthly walks and afternoons for carers. We have been very busy installing new technology equipment and replacing furniture in our training rooms to enhance our learning spaces.

Through the support of Knox Council, we have been able to offer community lunches which have provided a wonderful opportunity for people to connect and celebrate important events like Chinese New Year, Neighbourhood House Week and Harmony Day. Knox Council also provided a small grant to enable us to offer two important programs to combat social isolation through our Connecting through Craft afternoons as well as bridging the digital divide with our tech drop in sessions. We were successful in receiving a Bendigo Bank grant that will enable us to improve the street scape to make it more vibrant and inviting. We have installed a street library, weatherproof frames - with more exciting things to come!

Sandra has again shone in her Finance and Compliance role and her expertise are an invaluable asset to Orana. This year we were fortunate for Margaret Legwidge who returned after an extended leave. I am very excited about what the future holds for Orana Neighbourhood House and our gorgeous community and am looking forward to what we will all achieve together in the coming year.


About Us

Notes to the Financial Statements

For the Year Ended 30 June 2024

The financial report covers Orana Neighbourhood House Inc. as an individual entity. Orana Neighbourhood House Inc. is a not-for-profit Association, registered and domiciled in Australia.

The principal activities of the Association for the year ended 30 June 2024 were to provide programs and community space to the local community.

The functional and presentation currency of Orana Neighbourhood House Inc. is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

In the opinion of the Management board the Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Australian Charities and Not-for-profits Commission Act 2012.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

The Assoication has adopted the amendments to AASB 101 Presentation of Financial Statements which require only the disclosure of material accounting policy information rather than significant accounting policies and therefore policy information which does not satisfy one of the following requirements has been removed from these financial s tat em en ts:

Relates to change in accounting policy
Policy has been developed in the absence of an explicit accounting standard requirement
Documents an accounting policy choice
Relates to an area of significant judgement or estimation
Relates to a complex transaction and is required to explain the treatment to the user.

These special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

2 Material Accounting Policy Information

(a) Revenue and other income

Revenue from contracts with customers

Revenue is recognised on a basis that reflects the transfer of control of promised goods or services to customers at an amount that reflects the consideration the Association expects to receive in exchange for those goods or services.

Generally the timing of the payment for sale of goods and rendering of services corresponds closely to the timing of satisfaction of the performance obligations, however where there is a difference, it will result in the recognition of a receivable, contract asset or contract liability.

None of the revenue streams of the Association have any significant financing terms as there is less than 12 months between receipt of funds and satisfaction of performance obligations.

2 Material Accounting Policy Information

(b) Income Tax

The Association is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(c) Property, plant and equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment.

Depreciation

Property, plant and equipment, excluding freehold land, is depreciated on a straight-line basis over the assets useful life to the Association, commencing when the asset is ready for use.

Leased assets and leasehold improvements are amortised over the shorter of either the unexpired period of the lease or their estimated useful life.

The depreciation rates used for each class of depreciable asset are shown below:

Fixed asset class	Depreciation rate

(d) Financial instruments

Financial assets

Amortised cost

The Association's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Trade receivables

Impairment of trade receivableshave been determined using the simplified approach in AASB 9 which uses an estimation of lifetime expected credit losses.

The amount of the impairment is recorded in a separate allowance account with the loss being recognised in finance expense. Once the receivable is determined to be uncollectable then the gross carrying amount is written off against the associated allowance.

Financial liabilities

The financial liabilities of the Association comprise trade payables.

3 Critical Accounting Estimates and Judgments

The Management Board make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.
