A Year of Growth and Community Connection

Looking back on my first year as President of the Orana Neighbourhood House Governance Board, I feel incredibly proud of what we've achieved as a community. Orana Neighbourhood House truly shines as a guiding light in the City of Knox.

Our Mission in Action

This year, we've stuck to our main goal of boosting mental health and cutting down on social isolation by offering a friendly and safe spot for our community to connect, learn, and grow together. Our mission is more important than ever as we keep seeing the effects of social isolation and loneliness around us.

Community Impact

At Orana, we're all about making sure everyone in the community can join in on our programs without breaking the bank. We're dedicated to offering top-notch, affordable adult education and activities that boost wellbeing, spark creativity, and help people connect socially. Our spaces have never been so utilised, and we're thrilled to see capacity thresholds reached.

Partnerships and Support

We're super grateful for the awesome support from Knox City Council, the Adult Community and Further Education (ACFE) program, Department of Families Fairness and Housing, and many other supporters.[1] These partnerships help us keep delivering important services to our community.

Our incredible volunteers are the heart and soul of our organisation, putting in loads of hours at reception, in the gardens, running programs and hosting the three local Living Our Best Life, Talking Cafes. Their dedication truly embodies the spirit of neighbourhood houses.

Challenges

We're facing some financial challenges, like many Community Houses. Our revenue has gone up (thanks to the awesome planning by the Orana Team), but so have our costs for resources and wages. There are fewer grant opportunities and less overall funding available. Our usual funding sources aren't even keeping up with the rate of inflation.

On the bright side, we're now a registered charity, and early in 2026, Orana Neighbourhood House will roll out a fresh three-year strategy to guide Orana to explore new or alternative funding opportunities.

Looking Forward

As we head into the new year, we're all about backing our community. We're keen to keep breaking down learning barriers and boosting our ties with local social housing. We're are excited to build on the awesome intergenerational projects we've got going with the local secondary school.

Acknowledgments

Our tutors and teachers are fantastic, and it's awesome how we all chat like mates. It's so great to see the smiles on the students' faces as they walk through the door after class or share how much they enjoyed their session.





Family Learning Partnerships

In 2024 Orana was successful in receiving funding through the Family Learning Partnerships program. The aim of the program is to assist families that may be experiencing barriers to study and employment. Through the FLP, the Adult Centre For Education (ACFE) offers Learn Locals, \$35,000 over two years to achieve their outcomes. Keira de Hoog became Community Engagement Officer and began mapping out local organisations to meet with in order to reduce barriers and increase the awareness and access for local families to the offerings at Orana. Our focus was to reach out to Culturally & Linguistically Diverse (CALD) communities and parents in the local area who have family caring commitments. The FLP provided multiple options for them to access Orana through formal and informal engagement activities. We also undertook outreach work beyond Orana to increase our public profile in the local area.

Significant partnerships made through the FLP have been Swinburne University, who had CALD community members and parents who needed additional support to enrol in their accredited courses. We started off with a few meetings with SwinLocal, a partnership organisation between Swinburne University and Learn Locals in the eastern suburbs. SwinLocal then invited us to join their 'Boronia Revitalisation Project', whose main aim was to develop pathways from pre-accredited training to accredited training and help locals find work within the care sector.









In consultation with staff from Swinburne, we added a pre-accredited course, 'Introduction to Working in the Health Services Sector', to our program. We ran 4 intakes of classes at Orana with trainers from Swinburne. This course was then a direct pathway to the Certificate III in Health Services Assistance at Swinburne Wantirna. We also offered 4 new general courses that students could do to assist their transition to study and work.

We learnt a lot during this process and also connected with employment agencies in the area to help with the transition of students from study to work. Since running the health course, we continue to meet with Swinburne staff to develop and roll out more general ACFE courses like Be Study Ready or Gaining the Edge to help a wider cohort of students succeed in their studies. Referral pathways have been opened between Orana, Swinburne and employment agencies and channels of strengthened communication that were not there before.

Another significant organisation we connected with through the FLP, was Community Housing Ltd. They opened a new social housing complex just 5 minutes away from Orana, that included 118 units with new residents who had a variety of different needs and barriers. We joined the 'Wantirna Activation Group', a group made up of Community Housing officers, Knox City council officers and centres such as ourselves, in order to discuss ways to meet the needs of residents. We attended their Welcome BBQ once people had moved into around 40 of the 118 units. We were able to tour what will become their community room on the ground floor. Which we discussed as another potential offsite classroom for our pre-accredited programs such as English Language Conversation.

Since the largest barrier to employment and community connection was identified as language, we began to run our English conversation classes onsite there, and they have since expanded to two sessions of absolute beginners/ intermediates. We have also applied for the Knox Council Community Development grant together with Community Housing Limited to build up their health and wellbeing activities to offer residents. This will continue our connection and residents' connection in community and enrolment in jobs and skills courses in future.

Whilst these were targeted partnerships, we also continued to work on informal relationships to diversify our centre. We began running low-cost one-off kids workshops in the school holidays. Orana used to be a three year old kinder and occasional childcare centre up until 2013, but since then it had only run activities for adults. The Knox School were also looking to connect with the community and collaborate with some mutually beneficial projects that their students could get involved with. Orana agreed to collaborate with their Year 9 students on several projects such as improving our gardens and buildings.

The FLP has been pivotal in expanding the reach and ability of Orana to reduce barriers for community members. We hope to continue building, tweaking and collecting feedback to improve links with local organisations and even industry.









Giving Back

We were proud to host regular free Carers Afternoons on Tuesdays at Orana throughout 2024/25, focussed on health and wellbeing with highlights such as creative journaling workshops to set intentions and goals, sound bath relaxation session and henna with a high tea. In October carers were taught how to create their own kokedama plants with our horticulturalist, Liz.

We also teamed up with Life Saving Victoria to run a free CPR for Seniors workshop. Participants learnt proper CPR techniques, emergency response and how to use a defibrillator.

Our Patchwork Project group also handed over an incredible 101 quilts to Ronald McDonald House. Their beautiful and cheerful quilts go directly to sick children in Monash Hospital to bring cheer to challenging times. A huge shout out to Noelle from our Patchwork group - she also knitted 70 hats for the Father Bob Foundation, to provide warmth to people sleeping rough.









Women's Peace Retreat

A truly special Women's Peace Retreat was held on a weekend at Orana in August 2024. Local women signed up to come together and participate in a day just for them, with sound bathing, flow chi routines, tapping, a cacao ceremony, connecting with their inner child, and enjoying a delicious cooked lunch and conversation and laughs together. It is so important to provide a safe and healing space for women to put themselves first for once. Thank you to Suzie for making it so special and everyone who attended.









Adult Learners Week

In September 2024 we celebrated all of our lovely learners at Orana with a community lunch for Adult Learners Week! We love the community and energy and lifelong learning our participants bring each week to our centre.

Enormous thanks to the Bendigo Community Bank of Wantirna for attending the event and financially supporting our new community book library — it was unveiled amidst much fanfare!

Thank you to the Rowville Men's Shed also for constructing the Little Library - what a gorgeous addition to our fence. We love it so much and it has been used often since by passers-by. We even have a rock snake underneath it, made up of painted rocks by local children called Mr. Smiley.



School Holiday Programs

Since September 2024, Orana has been running two days of school holiday activities each break—and the kids have been having an amazing time!

They've enjoyed everything from sneaker decorating, to clay animation, to learning about art with nature, collecting and painting foliage, planting and harvesting produce from our gardens, cooking and doing yoga! We hope to continue running these wholesome programs with our wonderful facilitators, Anne, Sherie and Liz and look forward to our expanding our offerings for kids in 2025/26.













Seniors Week

In October 2024 we held a Superfoods workshop for Seniors Week, which was a resounding success! Thanks to everyone who came and sampled everything from cacao drinks to blueberry and avocado smoothies, to turmeric rice and matcha teas.

The role of nutrition in supporting brain health is vital for seniors in our community. In the workshop, 12 brain boosting health foods were demonstrated as to how you can incorporate them into your diet to improve brain health, provide protection against free radicals. These foods have anti inflammatory effects, and increase blood flow for optimal brain cell function. They have also been found to improve mental health and lower the risk of age related cognitive decline. We thank everyone for coming to learn more and improve their health!









Summer Garden Party

We had a fabulous time hosting the Orana Neighbourhood House End of Year Summer Garden Party with the local community in December 2024! Everyone wore something summery, and enjoyed a BBQ, mini craft market, outdoor games, and tropical drinks!

We love holding these events to celebrate friendships and learnings from the year.










New Website

Talking Cafes

Notes to the Financial Statements

For the Year Ended 30 June 2025

The financial report covers Orana Neighbourhood House Inc. as an individual entity. Orana Neighbourhood House Inc. is a not-for-profit Association, registered and domiciled in Australia.

The principal activities of the Association for the year ended 30 June 2025 were to provide programs and community space to the local community.

The functional and presentation currency of Orana Neighbourhood House Inc. is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

In the opinion of the Management board the Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the *Australian Charities and Not-for-profits Commission Act 2012.*


